### Install Gun Lock


Install SC-1 onto hinge (A) (part No. SC-9302) and install the hinge (including SC-1) onto 30" Universal Rail (B) (part No.: SC-9230).

Install Butt Plate (No. SC-1900) on L-bracket (part No.SC-9903) as illustrated, using allen screws and metal screws provided with the butt plate.
